WHEREAS, the BFP regional Bids and Awards Committee (BAC) was constituted to ensure transparency, accountability and adherence the ethical standards of public officials for the procurement of goods, consulting services and infrastructure projects;

WHEREAS, Section 7.2 of the revised Implementing Rules and Regulation (IRR) of RA 9184 states that, "No procurement shall be undertaken unless it is in accordance with the approved Annual Procurement Plan (APP) of the procuring entity. The APP shall bear the approval of the Head of Procuring Entity (HOPE) to act in behalf and must be consistent with its duly approved yearly budget".

WHEREAS, on 18 January 2017, DILG SECRETARY ISMAEL D SUENO ISSUED Department Order Number 2017-20 Re: Amendment to Department Order Nos. 2013-12 and 2015-172 regarding the "Strengthening of the Bids and Awards Committee and its Secretariat" and Department Order Nos. 2015-1005, 2015-946, and 2016-664 regarding the composition of DILG Bids and Awards Committee (DILG BAC), Central Office Bids and Awards Committee (COBAC), and Secretariat. The APP and corresponding resolutions recommended by the BAC, regardless of amount, shall bear the approval of the HoPE or his/her duly authorized official;


